REASONS TO BE CONNECTED

Welcome to the New Year! May 2020 be a good one for all of you!

In an effort to make town information and forms more easily available to you, the Town Board is looking into updating the Town's website later this year. If or when we have new web information and/or if email addresses need to be changed, we will let you know promptly.

DOG LICENSE CHANGES GO INTO EFFECT

Residents of the Town of Holland should remember to take care of licensing your dog. Per State Statute, all dogs over 6 months of age are required to be licensed. A rate change has gone into effect this year.

Spayed/neutered dogs are \$5 and non-spayed, non- neutered dogs are \$10. A license form is available on the Town of Holland website. Please send the form and your payment payable to the Town of Holland, along with a copy of the veterinary verification showing rabies vaccination dates and serial numbers to Gloria Kennedy, 7928 St. Pat's Church Rd. Greenleaf, 54126, and the license will be returned to you via postal service.

In addition, the Town Board has created a Dog & Kennel Ordinance to help define management of dog and/or kennel issues. This ordinance is posted on the town's website.

2020 SCHEDULE FOR YARD WASTE DROP OFF

The Yard Waste Program in the Town of Holland has become a popular service used by many of our residents. The dumpster is located at the south end of the parking lot at the Hollandtown Community Park on County D in Hollandtown, and is open from 8 am until 12 pm (noon) on the following Saturdays:

April 18*, May 16, June 13, July 18, August 15, September 12, October 10* and Oct 24*. See below for acceptable items.

April 18, October 10 and 24 will also have an area set aside for branches only which will later be chipped up by Brown County.

Note that May 16 will also be the Appliance Recycle Date at the same location. This is intended for Town of Holland residents, only. We are seeking a couple extra volunteers to help on this date. See below for acceptable items.

NO ITEMS ARE TO BE DROPPED OFF AT ANY OTHER TIMES EXCEPT DURING THE SCHEDULED DATES & TIMES. Items left outside the dumpster after hours are subject to a \$200 fine per town ordinance.

If you have questions or concerns, or need drop off at other than the posted dates, please call Mark at 920-540-8141. Any organization or student look for/in need of community service hours, please contact Mark.

ACCEPTABLE YARD WASTE includes, but is not limited to:

Branches (less than 6" diameter) Grass Clippings Leaves Hay/straw Brush Shrubs

Only yard and garden waste, and small brush will be accepted.

Yard waste must be in paper bags or trash cans for dumping. NO PLASTIC BAGS of any kind will be accepted.

PLEASE DO NOT MIX YARD WASTE WITH ITEMS THAT ARE TO BE CHIPPED.

Grass clippings will be accepted, however, the Town of Holland and the DNR encourage residents to leave the grass clippings on the lawn as a good source of fertilizer.

The dumpster will be locked before and after the times listed above

No other items will be accepted.

APPLIANCE RECYCLING EVENT: SATURDAY MAY 168 AM - NOON

Free Items: computer towers, laptops, cell phones, servers, wire & cable, keyboards, mouse, copiers, printers, fax, phone systems, DVD/VCR, stereos, CD players, rechargeable batteries, washers, dryers, stoves, household appliances big & small, anything metal

Items for a fee: Monitors \$10, TV's \$20, LCD TV's \$20, TV's over 30" \$40, Console TV's \$40;

Freon items: \$10 each

FORMS AVAILABLE ON WEBSITE

In order to help residents of the Town expedite business more efficiently, several commonly used forms are now available on the Town's website. Please find the following forms at www.holland-wi.us

- A) Request for Building Permit, Request to Re-zone, and Request for Conditional Use Permit forms are there for your use. You may fill them out and then submit them to the Town Clerk, Bill Clancy, in a timely manner for addition to the agenda for consideration at the following Town Board meeting. The Re-zoning and Conditional Use Permit application would then be reviewed by the Plan Commission and then set for a Public Hearing. The Informational Building Permit would be reviewed by the Plan Commission which would then recommend it to the Town Board for approval or denial. If approved, the proposal will be presented to the Building Inspector, Marty Johnson (920) 685-6755 to obtain the building permit.
- B) Certified Survey Map Review How to Obtain a Certified Survey Map (CSM) Approval for a lot under 10 acres. The steps which need to be taken to review a proposed CSM are posted in this document.
- C) **Comprehensive Plan-**Approved September 2018. The new Comprehensive Plan approved in 2018 is now on the website. The 143 page booklet is also on file with Clerk Bill Clancy.
- D) 2019 Dog Ordinance, and Dog Kennel and Dog License Application Form. Information for management of dog kennels, and dog license and kennel forms are posted on the web. Note that new fees have gone into effect at the start of 2020.
