- _____ Complete any requirements determined by the Plan Commission.

- _____ Contact town of Holland Building Inspector Mary Johnson at 920-685-6755 to apply for a building permit. You need both a permit and inspection for the following:
 - a) to build a new dwelling or building, or
 - b) to make any additions or structural changes to a dwelling or building.
